The plan has failed to identify an opportunity to provide a site in Yelverton for downsizing or retirement dwellings.

There is a site just off Gratton Lane Yelverton that has been promoted for downsizing and retirement units. A previous consultation exercise in 2016 highlighted the support for downsizing units in Yelverton. The site at Gratton Lane is available and given the positive local response to downsizing it should be allocated for this purpose. The NPPF and recent government guidance supports the provision housing specifically for the elderly as set out in the planning practice guidance 001-019 reference ID: 63-004-20,190,626 which states The need to provide housing for older people is critical. People are living longer lives and the proportion of older people in the population is increasing. In mid-2016 there were 1.6 million people aged 85 and over; by mid-2041 this is projected to double to 3.2 million. Offering older people a better choice of accommodation to suit their changing needs can help them live independently for longer, feel more connected to their communities and help reduce costs to the social care and health systems. Therefore, an understanding of how the ageing population affects housing needs is something to be considered from the early stages of plan-making through to decision-taking.

The site is well related to Yelverton, the access to the site is supported by the Highways Officer, the site is well screened from wider views.

The allocation of the site for this specific purpose should be supported in the plan.
